



Memorandum of Understanding between Khyber Pakhtunkhwa Information
Commission and Centre for Governance and Public accountability
(CGPA)

The Khyber Pakhtunkhwa Information Commission (Hereinafter referred to as the first party) and the Centre for Governance and Public Accountability (Hereinafter referred to as the second party) have reached a mutual understanding to Improve Citizens' Rights to Information in Khyber Pakhtunkhwa.


To give this mutual understanding a formal shape, the parties hereby agree to sign the following Memorandum of Understanding (MOU):-

The Khyber Pakhtunkhwa Information Commission (Herein after referred as the first party) and Centre for Governance and Public Accountability (Herein after referred as the second party) haven reached a mutual understanding to improve Citizens Right to Information in Khyber Pakhtunkhwa Province.

Both parties agree to sign the following memorandum of understanding (MOU):-

- a) Second party will continue its support in the capacity building of PIOs, Journalists, Local government representative etc. first party will support the second party in the conduction of capacity building program (first party support extends to invitation to participants, presentation of KP Information Commission and media coverage)
- b) First party will support the second party in organizing seminars at district and provincial level which strengthen implementation of Right to Information law, (first party support extends to invitation to participants, presentation of RTI commission and media coverage)
- c) Second party has initiated development of district website under section 4 &5 of the KP RTI law 2013, first party will extend its support in the Implementation at selected district and at provincial level
- d) Second party has installed citizen's complaint tracking system at RTI commission of which limited access will be given to citizen's to track their complaints. Second party will be responsible for the maintenance of the citizen's tracking system for a period of one year. First party will make sure the implementation and sustainability of complaint tracking system.
- e) First party will support second party in indexing and digitization of public record of public department at selected district and at provincial level.
- f) Second party will support first party in development and publication of material on KP RTI Law 2013.

- g) First party will continue running of help-desk center already established by second party in RTI commission.
- h) First party will support second party in the implementation of community social audits. first party will address the public complaints launched in the social audit process at their top priority.
- i) First party will extend its support to second party in the implementation of RTI related field activities through RTI focal persons at divisional level.
- j) Second party will extend its support in awareness raising of citizen's on KP RTI Law 2013 awareness sessions, seminars and media campaign which may include print, electronic and social media.
- k) Second party will support first party in printing and publication of Awareness materials which may include leaflets, Brochures, Manuals, Annul Reports, PIO Registers, Act copies etc.
- l) Second party will provide all its support to first party as per the availability of funds to strengthen the implementation of KPRT law 2013 in KP.
