Organizational Background

CBER The Centre for Business and Economics Research (CBER) at the Institute of Business Administration (IBA) Karachi established with the mission of fostering a robust research culture, CBER aims to bridge the gap between academic theory and practical applications in the business world. By conducting cutting-edge research, organizing conferences, and publishing high-quality papers, the centre provides valuable insights and data-driven solutions to contemporary economic and business challenges. CGPA

Centre for Governance and Public Accountability (CGPA) is a not-for-profit, non-governmental, non-partisan, civil society organization working for the promotion of public accountability and good governance. CGPA was established in 2011, and registered in January 2012 under the Societies Registration Act, 1860. CGPA specializes in advocacy and public policy analysis and development. The establishment of CGPA stems from the realization that failure of governance and lack of public accountability has led to a trust deficit between state and society in Pakistan. The importance of good governance, rule of law and public accountability for stabilization and socio-economic progress cannot be underestimated. CGPA has strong interest in building better governance and public accountability in emerging challenges of food, nutrition, and public health in Pakistan and elsewhere, too.

Each party agrees that information need not be marked as confidential to be considered and treated as such under the terms of this clause.

All such confidential information shall be considered proprietary unless it is provided specifically for disclosure to the public or other entity. This confidentiality obligation survives the termination of this MoU.

7. Settlement of Disputes:

☐ The parties shall use their best efforts to settle amicably any dispute, controversy, or claim arising out of this MoU.

Any dispute, controversy, or claim between the parties arising out of this MoU which is not settled amicably in accordance with the foregoing paragraph shall be referred to arbitration.

Failure by either party to enforce a provision of this MoU shall not constitute a waiver of that or any other provision of this MoU. The invalidity of unenforceability of any provision of this MoU shall not affect the validity of enforceability of any other provision of the MoU.
